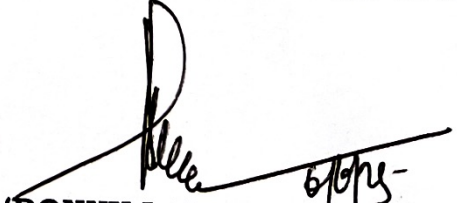
2. Adoption of The Mizoram Street Vendors (Protection of Livelihood and Street Vending) Regulations, 2017.

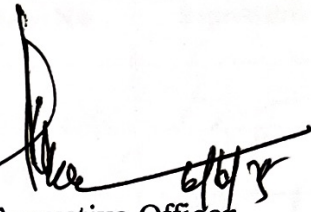
