3. Vawk in hi thenawm in hnai ber leh vantlang kawng atanga Ft- 50 aia hla ah sak tur a ni. Amaherawhchu LMC Area a Veng hrang hrang hmunhma azirin Local Council ten an ngaihnhathiam thei ang.
4. Lunglei Municipal area chhunga vawk vulh reng reng fel taka chhinchhiah tur a ni
 - a. Local Council kaltlangin veng tinah vawkvulh ten registration tih fel thlap tur a ni. Registration tih hun leh a fee zat te, registration tih dan tur chu LMC in ruahmanna a siam thin ang.
