1.Revision of Parking Rates

Ngun tak a sawihona neih ani a, Office order Dt 19.03.024 ah parking rate hman tur hi tihchhuah a ni tawh a. Tun a parking rate hman mek hi AMC in a khawn dante leh mipui nawlpui atanga rawtna te thlirho a sawiho a ni bawh a. Parking rate siam that hi public parking tender kalpui mekte nen pawh inkaihna wih vek anih avangin remchang hmasa berah Vice-Chairman leh CEO LMC ten parking collector-te lo dawr a ,ruahmanna lo siampui turin ruat an ni .Hetiang ang hian rate thar tur duan chhin a ni :

1. Two Wheeler – Minute 4 chin / chhung parking fee khawn loh (free) nise, darkar chanve zelah Rs 5.00 lak nise
2. LMV & above - Minute 4 chin /chhung parking fee khawn loh (free) nise, darkar chanve zelah Rs 10.00 lak nise

Tin , parking rate ruahman thar hian parking collector te sum hmuh tur a khawih avangin kum khat a an sum pek tur atanga 10% tih hniamsak an nih tur thu sawipui ni bawh se tha kan ti.

2.Revision of Exemption List as per Control of Parking and Collection of Parking Fees Regulations ,2024

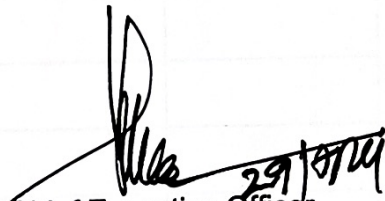
