5. Follow up action of declined Restricted tender works under SSP.

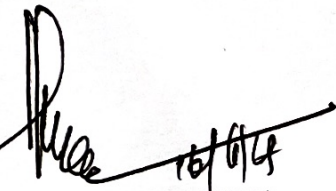

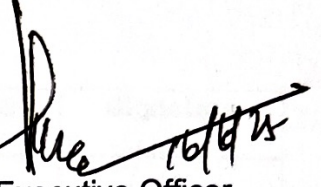
