chian a ni a. He building hi G+1 niin a chhakah extension/Annexe building a awm bawk a. Govt. Press-a thawktute hian room pahnih chauh an luah tawh avangin a bak zawng chu a ruak vek tawh a ni. UD&PA Deptt hnuia Senior Management Committee meeting Dt.26.5.2023 chuan he hmalakna hi tha a ti hle a, "Council of Ministers meeting hmasa bera ngaihtuah atan LMC-in Administrative Department-ah P&S building luah rawtna rawn thlen se" tiin thu a dah bawk a ni.

  - vi) Draft Lunglei Municipal Council (Licensing) Regulations.

- ii) Councillor-ten chawlkar khat chhungin Draft Regulations chu anmahni in lamah an lo zir chiang hmasa ang a, chumi hnu hun remchang hmasa berah Chairman hovin Councillors leh Official-ten sawi ho a ni ang.
- iii) Councillors leh Official-ten an sawi ho hnuah, zau zawka sawi ho a tul a nih chuan, mi dang sawm awmte sawmin sawi ho leh a ni ang.
- iv) Chumi hnuah Section 371(2) of the Mizoram Municipalities Act, 2007 (as amended from time to time) sawi angin, a duh apiang tan Draft Regulations enna hun thla khat chhung hawn a ni ang a, tualchhung chanchinbuah hemi chungchang hi puanzar a ni ang.
- v) Mipui lam atanga sawiselna leh rawtna a awm a nih chuan Executive Council-in a lo thlir ang a, a tul angin Draft Regulations chu a lo chul mam ang.
- vi) Executive Council-in a lo chul mam tawh chu Board of Councillors meeting ngaihtuah atan chhawp chhuah a ni ang.
- vii) Board of Councillors meeting-in a pawm fel atanga chawlkar khat chhungin sawrkar-ah thlen tur a ni ang.




