5. Serkawn Melte Road kawngsir a bawlhhlawh hal thin chungchang ah LMC in hmalakna neih tura tih.

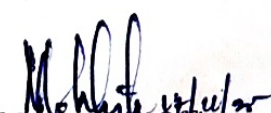
