

## **The Temporary Guidelines (Registration and Control of Dogs) Within Lunglei Municipal Council Area**

1. Lunglei Municipal area huam chhunga Ui vulhtute leh la lut tute reng rengin, kum khat zel atan registration an ti ngei tur a ni a / emaw an lak luh atanga ni sarih chhungin registration hi tih ngei tur a ni. Registration hi Form A hmanga tih tur a ni a, Registration ti lo te chu Registration an tihna man let sawm aneitute hnenah chawitir theih an ni ang.
2. a) Registration Form te hi Local Council hnenah application an dil rual a pek an ni ang a. Registration Form emaw Renew na emaw License pe theitute hnena an thehluh rualin Veterinary Doctor hnen atangin an Ui kawl lai chu eng natna mah aneilo a ni tih chianna Certificate an thehlut tel thin tur a ni. Hetah hian Ui chu chennain leh sumdawnna hmun-ah te kawl a him tih a chuang tur a ni. b) Local Council ten Tax an khawnna Register tha takin an vawng tur a ni a, an chawitir (fines) te chu Local Council fund ah dah tur a ni ang.
3. Ui Register tawh te hi Local Council ten an register ngei a ni tih fiahna atan Token an pe ngei tur a ni ang.
4. Registration tih hnuah Ui Vulhtu zawng zawng te hian an registration number lanna Token hi an la ngei bawk tur a ni.
5. (i) Registration Fee te hi Local Council ah pek tur ani.
  - (ii) Ui pakhat tan a hnuai ami ang hi Registration Fee a ni ang.
    - (a) Registration tihna atan - Rs 100/-
    - (b) Renew na atan - Rs 50/-
6. Registration hi thla sawmpahnih (Kum khat) a dam ang.
7. Ui Registration tihna Register hi Local Council tinin an vawng ang a, chutah chuan a neitu hming, chenna address kimchang leh Ui engzatnge Register an neih tih te chiang tak a ziah tur a ni.
8. Hremtheihna te:
  - (a) Registration neilo Ui te chu neitu awmlo anga ngaih tur a ni. Hetiang Ui, khawlai a tla mai mai, a neitute in chhuah san hi Local Council ten thuneihna an pek te hnenah hrem/tih ral theih a ni ang a (Sec 176 of MMA Act 2007 as amended in 2015 angin) emaw lilam theih a ni anga, kar khat chhung neitu hriat anih loh chuan tih riral theih a ni ang. Hetiang Ui te hi nitin Rs 300/- emaw a aia tlem emaw a neituten a hrenna hmun Committee in a ruat a hren anih chhung hi an chawi thin ang.
  - (b) Ui neitu reng reng in an Ui te khawlai emaw vantlang hmun emaw mimal hmunah emaw an vah tir mai mai tur ani lo a, hetiang ti an awm anih chuan Rs 500/- thleng fine tir theih an ni ang.
  - (c) Ui vulh te hian mi an seh emaw/ bei emaw anih chuan Rs 10000/- emaw a aia tam emaw, a tuartute hnenah an pe tur a ni. Chumi piah lamah damdawi lam a

enkawl ngai annih chuan an in entirna na leh damdawi atana senso zawng zawng an tum bawk tur a ni.

(d) Ui neitute hian an chawi tur hi an chawi duhlo anih chuan dan dinglai BNS  
Section 223 anga hrem theih an ni ang.

9. Local Council te hian atul dan a zirin Ui neitute hnenah emaw, Ui enkawltu hnenah emaw, Ui in natna a vei emaw a vei ni a rinhlelh emaw a awm anih chuan hmun ruat bikah rawn dah turin an ti thei bawk ang. License pe chhuak tute hian chu Ui chu tih hlum emaw Veterinary hospital ah enthlak turin ni sawmli ai tamlo thawn turin an ti thei anga, he ta hren anih hun chhung senso zawng zawng hi Ui neituten an tum tur a ni.

10. He rules hian Municipal area a Ui ennawm chhuahna (Dog Show) tur a rawn ken luh te a huam vek ang a, nitin Rs 50/- chawitir an ni ang.

11. Hmunhma endik theihna:- Municipality emaw Local Council in emaw a tul dan azirin mawhphurtu bik a ruat thei ang a chu chuan:-

- (1) Ui eng pawh a endik thei ang a/emaw khawi hmun pawh Ui enkawlna a endik thei ang.
- (2) Sawrkarin ti tura a ruat dang te pawh tih theihna a nei bawk ang.
