

## **GUIDELINE FOR PIG REARING IN LUNGLEI MUNICIPALITY**

1. Lunglei Municipal huam chhunga vawk vulh duh te chuan Local Council leh chenna in hnai ber te nen a endik anih hnuin Chief Executive Officer, Lunglei Municipal Council hnenah dilna an thehlut ang.
2. Vawk vulh dilna lehkha ah hian Chairman, Local Council remtihna lehkha thil tel tur a ni.
3. Lunglei Municipal Council in dilna te a enfiah hnu ah phalna a pe ang.
4. Lunglei Municipal area chhunga vawk vulh reng reng fel taka chhinchhiah tur a ni a. Local Council kaltlangin veng tinah vawk vulh ten registration tih fel thlap tur a ni.
5. Registration tih hun leh a fee zat te, registration tih dan tur chu LMC in ruahmanna a siam thin ang.
6. Lunglei Municipal Council huam chhungah midangte tana hnawk leh rimchhia te, a thli enkawl lova leimin leh harsatna dang thlen thei zawngin vawkvulh hi kalpui tur a ni lo.
7. Vawk vulhtuten hetiang hian an vawk te hrisel nan leh an vawk vulhna hmun ti thianghlim turin hma an la ngei ngei tur a ni:
  - (a) Vawk in hi tha taka sak tur a ni a, hmun him leh min mai thei lovah sak tur a ni.
  - (b) Vawk zun leh ek thli te inchhekkhawl lovin an tifai tha tur a ni a. Vawk leh a in hi an silfai thain an ti thianghlim tur a ni a. Heng thli te hi leia luang ral leh inchiah ral mai lovin drain tha tak siamin an la khawm ang a, tuiluankawr hnai berah an zawm tir ngei tur a ni.
  - (c) Thenawmte leh Vantlang tana rimchhia in an siam tur a ni lo.
  - (d) Vantlang kawng, kawngpui leh lui hnaih lutuk ah vawk in hi sak loh tur a ni.
  - (e) Vawk vulh tuten an ran te hriselna an ngai pawimawh tur a ni a. Vawk hri leng thin laka inven nan vawk in hi a theih chuan inzawm lova sak ni se, vawk vulh te pawh LMC/AH&Vety Doctor te endik tir thinin a hun takah deworming tih thin te, vaccine lak tir te, Sawrkarin biosecurity measure a siam te tha taka zawm thin tur a ni.
  - (f) Vawk dam lo awm palha dah hranna tur neih theih anih chuan a lawmawm hle ang.
8. Vawk vulhna hmun te hi Ward Committee leh Local Council ten an endik thin ang.
9. Vawk vulhtuten vawk dam lo leh hrisel lo an hrall tur a ni lo.
10. LMC area vawk vulh registration ti lo te leh inkaihruaina dan zawm lo te chu Section 374 of the Mizoram Municipalities Act 2007 (As amended from time to time) hmangin emaw Section 11 of the The Mizoram Animal Slaughter Act-2013 hmangin hrem theih an ni ang.
